Considered the action taken by the Vice-Chancellor under section 17(4) of the Haryana Private Universities Act 2006 in approving the following recommendations of the committee with regard to establishment of Academic Chair in the name of Guru Gaurakshaknath Ji in this University, (Annexure-III, pages 05 to 06 already circulated):-
 - 1. Guru Gaurakshaknath Ji Chair be established in the University from its own funds.
 - 2. This Chair may be established either in the department of Hindi or Sanskrit. The Director of the Chair may be appointed from the above said Departments in the addition to his own duties. Office room and other infrastructure required for the said chair may also be provided in the concerned department for the smooth functioning of the chair.
 - 3. Research on Guru Gaurakshaknath Ji may be carried out in the various departments of the Faculty of Humanities. Ph.D. Research Scholars may be enrolled accordingly in all the concerned departments, wherever feasible.
