Whereas, The Haryana State Bharat Scouts And Guides informed The Baba Mastnath University (as per the Guidelines of the National headquarters) regarding introduction of Roving & Ranging in the Universities in the State of Haryana, with view to shape and build the Character of the young people through inculcating values of self-discipline, social service and patriotism.

Whereas, Baba Mastnath University and BSG Haryana enter into MOU for the scope and purpose as set forth in clause below.

Now therefore, in consideration of the mutual agreement and undertakings contained in this MOU, the parties agree as follows:-

1. Purpose, Scope of the MOU:-

This MOU provides for:

- a. To Train Students (as Rovers/ Rangers) of the University as per APROs (Aims, Policy, Rules and Organisation) and in accordance with the National Headquarter/ State Headquarter Guide lines from time to time.
- b. To provide opportunity to students and unit Leaders to take part in the State/National/ International level Camps/ Events/ Seminars/ Jamborees.
- c. Activities to be undertaken to improve the Physical & Mental fitness of the youth.
- d. To support youth with their Education beyond University, through various types of Adventurous/ Outdoor activities.
- e. To provide opportunity to take part in various campaigns, Nation Building activities launched by the State/Center at Govt.
- f. To promote Life Skill Education and personality development with the aim to be a responsible Citizen of the Nation.
- g. To arrange Training for Unit Leaders/ Rovers & Rangers in accordance with the scheme of the Bharat Scouts and Guides APROs.
- h. To hold the training Camps/ Events/ Seminars etc for the students and adult Leaders in the Campus of the University with mutual understanding of the authorities.
- i. To form organisational setup as per the rules of the Bharat Scouts and Guides.

2. Role & Responsibilities of the University:-

- i. Select a Male and Female to be trained as Unit Leaders for Rover and Ranger Section.
- ii. To appoint office-bearers of the organisation as per rules of BSG.
- iii. Will setup Rover and Ranger units in accordance with the organizational setup of the Bharat Scouts and Guides
- iv. Submission of affiliation fee and Individual registration fee annually as per the instructions issued by the State Headquarter from time to time.
- v. Make available premises for training of the Students as and when required.

- vi. Depute Students (Rovers/Rangers) for various types of camps/ events etc.
- vii. Organise various activities/ Day Celebrations in the university.
- viii. Organise Social service Events/ camps such as Blood Donation, Drug Awareness, Swatch Bharat- Sunder Bharat & Beti Bachooa, Jal Shakti Mission/Abhiyan.
- ix. To promote Rovers/ Rangers for Rashtrapati Certificate Examination & Up-Rashtrapati Award Competition.
- x. To abide by the Rules and By-Laws of the Bharat Scouts and Guides.
